Each pay period, the National Finance Center (NFC) makes the CULP0053, T&A Error Analysis Report available to our customer Agencies. The report is generated for our Agencies each time we run a Time and Attendance Validation System (TIME) job to update incoming T&A's. One of the benefits of utilizing the information provided in the CULP0053 Report is to increase your awareness of the need to process personnel actions timely and the importance of submitting complete and accurate T&A data, which would eliminate errors and increase efficiency of your payroll processing.

In addition, we encourage Agencies to use this information to enhance any T&A front-end systems/edits that you are currently using to eliminate common errors, lead to fewer rejected T&A's, and result in a more efficient and cost-effective payroll processing cycle.

Below are a few common TIME errors and the proactive Agency actions.

Error Code	TIME Edit Error Message	Required Agency Action
121	Advanced Leave Exceeds Leave Earned by Year End	<ul style="list-style-type: none">The number of advanced leave hours must not exceed the number of hours that the employee will earn during the remainder of the leave year. Advance leave should be verified before submitting the T&A.

Error Code	TIME Edit Error Message	Required Agency Action
144	Unexplained Split T/A or Status Change	<ul style="list-style-type: none"> Code the status Start and End date to match the date on the personnel action.
476	TC 17 Must Be 10 Hours if Special Employee Code = B2	<ul style="list-style-type: none"> Ensure the hours are pertaining to the appropriate special employee code before submitting the T&A. For example: B2 should have 5 hours in week 1 and 5 hours in week 2.

The CULP0053 Report is available on the Reporting Center under Administrative reports after each pass of TIME.
