### Minutes

1. **BI** – HANA ULO Report latest update. BI team is continuing to work to resolve performance issues and out-of-balances in HANA ULO. There are 2 proposed solutions in QA that are being tested. We will continue to keep you posted as updates become available.
  2. **Security** – No questions.
  3. **DATA Act Dashboard** – Lisa Smith, OCFO reminded Agencies that the DATA Act Dashboard cut-over date is expected on Friday, August 10th. The Go-live deployment is scheduled within one to two weeks. Agencies are encouraged to begin now completing the consolidated GRC Role spreadsheet requesting access rather than later when the format for submitting access will be one-for-one requests.
    - a. Melissa Montz added all requests will need to go through the Agency FMMI Security Administrator and CFO for approval, then emailed to OCFO, FMS, System Security chief for approval, and then a ticket is created for provisioning to take place.
    - b. AMS asked when will the roles be available? Roles should be available soon after it's goes live, available on Monday, August 13th. ## DATA Act Dashboard Role

### 1. *Role Description*

The DATA Act Dashboard role provides visibility to DATA Act data on the dashboard. The access can be granted to a single, multiple or ALL Business Areas. A Business Area represents a USDA agency or Federal Shared Services Customer

### 2. *Activities Performed*

It provides access to Dashboard metrics at a Summary and individual file level [File A (Appropriations), File B (Program Activity and Budget Object Class), File C (Award Financials by PIID/FAIN), File D2 (Award Attributes)]. The metrics are

- Fatal, Non-Fatal or Clean records
- Total and submitted record counts
- Age fatal errors
- Provide counts on key statistics like Treasury Symbols, Procurement ID Number, Financial Assistance Number, Program Activity and Budget Object Class

### 3. *Role Criticality (High, Medium, Low)*

The criticality of this role is Medium. Without this role agencies users will not be able to measure DATA Act compliance

### 4. *Magnitude of Change (High, Medium, Low)*

The magnitude of change for this role is medium. This a new role that was created strictly for use by DATA Act Compliance Dashboard. Please note these roles are not applicable to DATA Act reports

### 5. *Data Sensitivity Considerations*

All clean and submitted DATA Act data is publicly available. This role was created to secure visibility to errors and compliance by an agency
