1. The BI Team – HANA ULO Report latest update.

3. Open Discussion -

a. DTB sent a FMS Notification on 9/19/18 for the Ameresco BPA call.

- OCFO, Lisa Smith provided an update on the DATA Act FMMI Enhancement for the 4th quarter hard-stop edit warnings of FY18.
 Beginning FY19, these warnings will become hard edits for PO and Non-referencing FI documents that are potentially DATA Act reportable as outlined in OCFO Bulletin 17-02.
- c. CEC asked about the error list emailed to a small group of agencies? Agencies are required to capture PIID and FAIN data at the header level, not at the line item. Instructions for entering PIID and FAIN are included with OCFO Bulletin 17-02.
- d. NRCS asked if PIID or FAIN is not on PO level will invoice fail? Yes. For non-federal vendors, the PIID or FAIN must be on PO or processing will not continue.
- e. If a PIID or FAIN was entered incorrectly, can it be corrected? Yes and it should be corrected to ensure accounting information is picked up correctly.
