#### Scheduled FMMI Production System Maintenance

All FMS Production Systems, including FMMI, CPAIS Real and Personal Property, FSDW, ACRWS, RITA, and MINC, will be temporarily unavailable this weekend for regularly scheduled maintenance (monthly OS patching) beginning at 6 AM CT, Saturday (03/28/20), through 12 PM CT (Noon) Sunday (03/29/20).

#### FMS Annual Disaster Recovery (DR) Drill

FMS will be conducting its annual Disaster Recovery (DR) Drill exercise April 3rd - 5th. This will be a full DR Drill and will include all FMS systems (FMMI, CPAIS Real and Personal Property, FSDW, FCRWS, RITA and MINC). All production jobs, interfaces

and normal production access will be suspended during this DR period. In addition, all non-production systems will be unavailable during this DR period.

As a part of the DR activities and in preparation for Customer testing, FMS will redirect all network traffic from its production environment to its DR site. The redirect process is scheduled to begin approximately 7:00 p.m. CT on April 3rd, and complete prior to the Customer testing window the morning of April 4th. The DR testing is scheduled for 8:00 a.m. CT- 4:00 p.m. CT Saturday, April 4th.

FMS will work with its Cloud Partners, immediately after the DR testing window, to ensure that all network traffic is redirected back to the production environments.

As with past DR activities, any and all activity performed during the testing window will be discarded once testing concludes. FMS plans to have all systems back in their normal accessible productive states by 6:00 p.m. CT Sunday, April 5th.
