## **CSD Updates** – FIET Project

- FMMI Code Brown Out period: July 2023 May 2024
- FMMI Code Black Out period: June 2024 January 2025

### FMS Branch Notifications -

**Technical Operations Maintenance Branch (TOMB)** – OS patching maintenance for May 18-19, 2024, completed without incident. However, some BOBJ issues arose and will be handled during the next maintenance outage scheduled for June 22nd & 23rd.

### Agency Representative(s) – Comments/Questions.

• Several Agencies have difficulties pulling specific reports (e.g. FTRs, funds reservation or Ad Hoc reports status of funds, etc.) and the data is not updating immediately. Agency also request transparency, especially during yearend processing, regarding when the transaction data will be updated.

Basis's Team (Lee McMullan) – BOBJ is a <u>near</u>-real time system. Data is cached approximately every 120 minutes by design, depending on when report requests are kicked off and report frequency.

TOMB – (Gerald Spears) – When we transition S4-HANA, we will review this issue and provide agencies with information about data cache timing to help agencies improve report functions.

• OCFO (Janel Smoot) – We are receiving an error "locked by administrator" when add a forecast in the FMMI Budget Planning module. Is there a problem? Cherie – There were some issues last night with some jobs processing. The budget planning job kicked off this morning. So, it may have briefly locked you out. You can try again in about an hour.
