

On August 21, 2014, the following changes were implemented into the CPAIS Real Property Application:

FORMS

Agency Data Certification Form

- **Changes**
 - Added User ID field.
 - The new User ID field will be auto populated with the User ID of the user adding the record.
 - The new User ID field will be auto populated with the User ID of the user modifying the record.

Explorer: FRPP Assets Form

- **Additions**
 - **Tabs: Disposed Buildings, Disposed Land, Disposed Other Structures**
Added Installation ID, Installation Site and Installation Name columns as the last three columns.

Identify records missing Installation ID, Installation Site and Installation Name as data gap records.
- **Changes**
 - **Tab: Owned Other Structures**
Removed Using Org.
 - **Tab: Leased Other Structures**
Using Organization is no longer considered for gaps.
 - **Tabs: Owned Buildings, Leased Buildings, Owned Land, Leased Land, Owned Other Structures, Leased Other Structures**
Longitude will display as a gap if the value is outside the range of 180 to -180 when Longitude is not null.

Added data check to the data gap determination script to restrict valid Latitude will display as a gap if the value is outside the range of 90 to -90 when Latitude is not null.

Explorer: Property Form

- **Changes**
 - Fixed the Using Organization field List of Values (LOV).

Location Coordinates Pop-Up Form

- **Changes**
 - Added data validation edit to restrict valid Longitude values to the range of 180 to -180.
 - Added data validation edit to restrict valid Latitude values to the range of 90 to -90 on the Location Coordinates Pop-Up form.
 - **Launched from Maintain Property: Land Use Tab and Explorer Property: Land Use Tab:**
Changed the form title from Land Unit Location Coordinates to Location Coordinates.

Changed X Coordinate field title to *Longitude.

Changed Y Coordinate field title to *Latitude.

Changed Z Coordinate field title to Elevation.

Changed Z Coordinate field title to Elevation Unit.
 - **Launched from Maintain Property: Land Acquisition Tab and Explorer Property: Land Acquisition Tab:**
Changed the form title from Land Unit Location Coordinates to Location Coordinates.

Maintain Property Records Form

- **Changes**

- Fixed the Using Organization field List of Values (LOV).

Owned Property Form

- **Changes**
 - Fixed the Using Organization field List of Values (LOV).

Status History Form

- **Changes**
 - Users are prevented from entering a Status History record where Status = DISPOSED if the preceding Status History record Status is not EXISTING%.
 - When a user selects DISPOSED Status and the previous Status value is not EX%, the following pop-up message is displayed: “Asset has never existed according to the previous Status record. DISPOSED can only be used for assets that have been part of USDA’s actual inventory. If the record is erroneous, please contact your Agency POC for guidance.”
 - Removed all imbedded DISPOSED Status records for all but Forest Service asset records. A one-time report will be provided to all agencies with asset records having imbedded DISPOSED Status records. (“Imbedded” means one or more DISPOSED Status records with an Effective Date earlier than the MAX Effective Date Status record.)
 - **Regarding: Buildings – Status History; Land Unit – Status History; Other Features – Status History:**
Prevent Status values of %EXCESS% from being visible on the Status field LOV when an asset has a Property Type of USDA LEASED.

Prevent Status values of %GSA% from being visible on the Status field LOV when an asset has a Property Type value of STATE OWNED or FOREIGN OWNED.

Disposition Value is auto-populated with - .00 and data entry is prevented when the Disposal Method is Lease End (when the Property Type is USDA Leased or GSA Assigned).

Removed the error message/logic, “Disposition Value must be greater than 0 for disposal method LEASE END.”

System:

- **Changes**
 - Completed the data cleanup of the current CPAIS data to ensure the Country Code portion of the assets GLC reflect the New Country Codes provided on the GSA Website (<http://www.gsa.gov/portal/content/101553>) titled FRPP GLC List of Foreign Countries or the attached spreadsheet OPPM provided.
