# SPPS Web Special Payroll Processing System

The Special Payroll Processing System for Web (SPPS Web) is a Web-based application that allows establishment, adjustment, inquiry, retrieval, and deletion of certain manual payment and adjustment transactions. These transactions include:

- Cash awards/Special bonuses that cannot be processed in one of the Payroll/Personnel front-end entry systems
- Settlement back payments
- Compensatory time payments
- Credit hours payments
- Annual/Restored leave payments that cannot be processed in one of the Payroll/Personnel frontend entry systems
- Miscellaneous payments (allowances, differentials, bonuses, and payments)
- Student loan repayments
- SPPS Web is accessed from a Web browser, providing easy-to-use Web navigation.

#### Main Features of SPPS Web

- Process and maintain subject-matter manual payment and adjustment transactions on the SPPS database.
- Access manual payment and adjustment transactions for a separated employee.
- Calculate gross to net amount adjustments.
- Validate accounting codes against the Management Account Structure Codes System (MASC).
- · Release a record to NFC for processing.


- View and print NFC-29 computations and pay adjustment transactions.

- The number of telephone inquiries to NFC by the Agency will be reduced.


## **Supported Browsers**

### **Security**
