Scope:	<p>This project will provide employees with the ability to add or change their Ethnicity and Race Identification (ERI) Code, and change their Gender and Handicap Code online thru EPP/ESS.</p> <p>EPP will be modified to add a new Employee Self-Service window to provide entry of the data. The data will be sent to the P/P database as a Master File Change Document (30-document) via a FESI file.</p> <p>This project will impact the Employee Personal Page (EPP)/Employee Self Service, EPICWEB, PINE/PEPL, and EmpowHR. TMGT Table 038 must be updated with new "D" Field Number Codes for Gender and Handicap Code. ERI is already established as D00077.</p>

<p>EPP</p> <ul style="list-style-type: none"> -Modifications to EPP will be made using .Net technology. -EPP database change to add ERI, Gender, and Handicap Codes. -Create 2 new database tables, one for employee entered data and one for document status tracking -Update the EPP Payroll/Personnel extract to capture employee current data on the P/P database. -Modify mainframe programs to receive applied, future, & suspense data from P/P database & reformat to EPP format. -Modify the Self-Service page to provide access to an entry page, and display the employee's ERI code, Gender Code, and Handicap Code currently on the database. If a valid ERI Code is not present, allow the entry of a code for the first time. Display the Gender and Handicap code currently on the database and allow for a change only. -Create new web pages to display and capture new data. -Update Knowledge Base with help information. -Update EPP help to include these elements. -Create scripts to upload 30-document data from EPP database to FESI format. -Add OPM links for additional information. <p>Gender Code = SEX-CODE X(01) Valid values are "F" and "M".</p> <p>Handicap Code = PHYSICAL-HANDICAP-CODE 9(02) Valid values are on TMGT Table 025, and will be defined on the 1133/SRD.</p> <p>ERI = ERI-HISPANIC 9(01) ERI-NATIVE AMER 9(01) ERI-ASIAN 9(01) ERI-AFRICAN-AMER 9(01) ERI-HAWAIIAN-PAC-ISLAND 9(01) ERI-WHITE 9(01)</p> <p>Do not allow ERI to be all zeroes. Each ethnicity selected by an employee should be sent as "1". Those not selected must be sent as "0" (zero). All 6 positions must be sent on the FESI file.</p> <p>D00211 Gender D00212 Handicap Code D00077 ERI</p> <p>EPIC</p> <p>Make the following modifications to EPIC WEB only:</p> <ul style="list-style-type: none"> -Add Gender and Handicap Code to the field selection list on the Master File Change Document (30-document).

Handicap Code = PHYSICAL-HANDICAP-CODE 9(02) Valid values are on TMGT Table 025, Block 012.
