Scope:	The Personnel Processing Branch (PEPB) has requested modifications to the Table Management System (TMGT) as follows:  Table 063, Contact Types (Project 216249), Phase 1 Table 006, CFC Payee Address (Project 221674) Table 096, Dept. Building Codes (Project 221674)  This FRD only contains the requirements for TMGT Table 063 (Project 216249), Phase 1. Phase 1 consists of adding and renaming Contact Types for Empower, webTA, ABCO, CLER, DPRS and Manual Payments.  The remaining changes will be documented under Project 221674 at a later date.
Assumptions:	This enhancement to TMGT Table 063 will improve the effectiveness of the Consolidated Call Center.  Since all Department and agency SAC levels are currently defined in TMGT Table 63 (Department/Agency/Bureau), there are no security changes needed to TMGT to allow agency update access. To gain update access to Table 63 for their employees, the Agency Security Officer must submit a request to the ITSD Access Management Branch.
