The export (HREXP.sqc) is building the cancellations (001 and 007) for the history override packages (HCUP) incorrectly. It is currently building the cancellations either a 001 or 007 using the corrected history data. The HREXP.SQC needs to be changed to build the 001 or 007 cancellations in a HCUP package. The cancellations should be using the original history data (a snapshot of the current data) that is stored on the "History Override Reset Button" tables.
