
EmpowHR - Calendar Year (CY) 11 - Pay Period (PP) 04 Release 8 Release Notes

Effective Pay Period 04 (February 21, 2011) the following changes will be implemented in the *EmpowHR* system. A summary of the changes is reflected in the table below. A work email address will be required for all employees when the EHRI code is completed (Document Type 444). This email submission will facilitate the OPM Human Capital Survey.</p> <p>Note: This email will not affect any other email addresses used for workflow or email notifications received for <i>EmpowHR</i> transactions.</p>

00442	N/A	The purpose of this modification is to establish a new locality pay area OV for Foreign Service Overseas locality percentages. Locality-based comparability pay will be applied to Foreign Service Officers grade 01 thru 09 (pay plans FO , FP , and FS) serving overseas.
00481	Payroll Documents, Section 6	<p>In accordance with Section 5035.40 of 31 CFR, services performed outside a city or county should reduce the withholdings of city and county taxes only when the employee performs 25 percent or more of their services outside of the city or county.</p> <p>This modification will ensure that the <i>EmpowHR</i> City and County tax documents will not allow the entry of less than 25 percent of services performed outside of the city or county.</p> <p>If any city or county tax is less than 25 percent in the CITY-TAX-PERCENT and COUNTY-TAX-PERCENT fields on the Payroll/Personnel database the value will be changed to 0 (zero).</p>
